# Jefferson City Autoplex 1971 MG Midget Car Raffle Benefitting United Way of Central Missouri

## **Official Rules**

Jefferson City Autoplex is raffling off a 1971 MG Midget with all proceeds benefitting the United Way of Central Missouri. Purchase raffle ticket entries for \$5 per raffle ticket entry from United Way of Central Missouri ("United Way") at <a href="www.unitedwaycemo.org/JCAutoplexCarRaffle">www.unitedwaycemo.org/JCAutoplexCarRaffle</a>. There is no maximum number of raffle ticket entries to be sold. Odds of winning are based on the number of raffle ticket entries purchased. The entry deadline is October 27, 2017 at 5:00 p.m. CST. All participants, by virtue of their entry in this raffle, agree to be bound by the terms and conditions described in these official rules.

## **HOW TO ENTER**

There are two ways to enter.

- 1) Purchase tickets in person at United Way of Central Missouri, or at United Way of Central Missouri sponsored events during normal business hours; or
- 2) Purchase online at <a href="https://www.unitedwaycemo.org/JCAutoplexCarRaffle">www.unitedwaycemo.org/JCAutoplexCarRaffle</a> (Requires completion of the online entry form and payment of entry fee with debit or credit card.)

## **ELIGIBILITY**

Open only to legal United States Citizens who are 18 years of age or older as of August 31, 2017. All raffle ticket sales are final. Current staff of United Way of Central Missouri and Jefferson City Autoplex and their immediate family members are ineligible to enter. United Way of Central Missouri and Jefferson City Autoplex are not responsible for late, lost, damaged, incomplete, misdirected, illegible or mutilated entries. Winner must show proof of a valid driver's license and submit an affidavit of eligibility in order to claim the grand prize. United Way of Central Missouri and Jefferson City Autoplex reserve the right to revoke any prize or remove an entry if the entrant does not meet any or all of the eligibility requirements, or if the entry or winning tickets has been damaged or altered.

The raffle is void where prohibited or restricted by law.

All raffle ticket entries must be received by United Way no later than October 27, 2017 at 5:00 p.m. For each ticket purchased, the purchaser receives one entry into the drawing for the grand prize. In the event United Way and Jefferson City Autoplex choose to discontinue the sale of raffle tickets, a winner may be drawn from current eligible entries. ## **SELECTION AND NOTIFICATION OF WINNERS**

Winner will be selected in a random drawing on Thursday November 2, 2017 that will take place at the 2017 United Way of Central Missouri Victory Celebration, to be held at Missouri Farm Bureau, Jefferson City, Missouri, and results will thereafter be posted on United Way of Central Missouri's website. The winner does not need to be present at the time of drawing to win. Once submitted, entries become the sole property of United Way of Central Missouri and will not be returned.

#### **PRIZE**

One (1) Grand Prize will be awarded to one (1) raffle participant and will consist of a 1971 MG Midget, red, 2-door automobile. Approximate value: \$3,000. United Way and Jefferson City Autoplex make no guarantee as to the actual condition or market value of the Grand Prize at the time of delivery to the winner.

Upon verification of the winner, United Way of Central Missouri will notify Jefferson City Autoplex to finalize the transfer of the vehicle to the winner. The prize will be awarded in its then present, "as is", condition with no warranty of any kind. The winner of the drawing shall be required to provide the United Way of Central Missouri with a signed statement confirming their eligibility under these Rules and applicable law, proof of age and social security number.
